How do I sign up?

By completing this authorization form and returning it along with a voided check (if using your checking account) and a JCC Membership registration form (for new members) or a JCC membership renewal form (for renewing members). The check must be pre-printed with the members name and account number on it. We will then complete our verification process and issue your JCC membership card(s).

Terms and Conditions

1. I understand that this is a continuous plan (minimum of 1 month) and that this membership will remain in effect for as long as I retain the membership card issued to me.
2. I understand that if I wish to terminate after a minimum of 1 month or change my membership in any way, I must give the JCC a 30-day written notice. I understand that I must turn in all my membership cards upon termination.
3. I understand that if payments are not made in accordance with this plan, I surrender all membership privileges and program participation for all family members on my account.
4. The JCC Board of Directors may, at their discretion, adjust the monthly rate applicable to my category of membership once per year.
5. Should any membership deduction not be honored by my bank for any reason, I realize that I am still responsible for the payment, plus an administrative service charge.
6. Memberships are not refundable or transferable.
7. I understand that my checking account will be debited and/or my credit card charged on or about the 10th of each month. Unless I choose to pay in full, I will be automatically debited and/or my credit card charged the annual membership rate in full at my renewal date.

WAIVER, RELEASE AND INDEMNIFICATION AGREEMENT; PLEASE READ CAREFULLY

I, on behalf of myself and my family members and minors listed below ("I"), the undersigned, upon joining the Friedberg JCC agree to abide by the policies, rules, and by-laws of the Friedberg JCC.

I understand that engaging in the different activities and programs at the Friedberg JCC, are done at my own risk, and that it is my sole responsibility to ensure that I am in the proper physical condition to engage in such activities or programs. I understand and acknowledge that participation and/or observation in the programs offered by the Friedberg JCC, could in some circumstances result in physical injury, illness (including exposure to and infection with viruses or bacteria), and including death, despite all safety precautions, and that I assume all risks and hazards incidental to the programs or activities in which I engage.

Coronavirus, COVID-19 is an extremely contagious virus that spreads easily through person-to-person contact. Federal and state authorities recommend social distancing as a means to prevent the spread of the virus. Covid-19 can lead to severe illness, personal injury, permanent disability, and death. Participating in Friedberg JCC programs or accessing the Friedberg JCC facilities could increase the risk of contracting COVID-19. The Friedberg JCC in no way warrants that COVID-19 infection will not occur through participation in Friedberg JCC programs or through access to the Friedberg JCC, and on behalf of myself and my family members and minors, assume the risk of such illness, injury, disability and death in connection with COVID-19.

To the maximum extent permitted by law, I hereby release, indemnify, and hold harmless the Friedberg JCC, its employees, contractors, instructors, officers, directors, members, managers, agents and representatives, from any and all claims, loss, liability, actions, suits, expenses, damages, costs, or claims of any nature, in law or in equity, including attorney's fees and court costs, that may incur due to my presence and that of my family, in, upon, or about the Friedberg JCC premises whether due to observation, participation in, or use of the property, facilities, services, including but not limited to, the use of the swimming pool, use of the Friedberg JCC equipment, and participation in any and all programs offered by the Friedberg JCC Fitness Center, as well as activities, use, or participation in any affiliated programs.

I hereby assume full responsibility for and risk of loss and indemnify and hold harmless the Friedberg JCC, and its employees, contractors, instructors, officers, directors, members, managers, agents, and representatives, for any claims, liability, damage, loss, psychological or bodily injury (including death) which may be sustained as a consequence of the attending at or participating in any and all of the programs, or any other activity connected with the Friedberg JCC, including use of the facilities and equipment, and transportation to and from these programs, notwithstanding any such damage, loss, psychological, or bodily injury (including death) may have arisen out of the negligent acts or omissions or the gross negligence of the Friedberg JCC, and its employees, contractors, instructors, officers, directors, members, managers, agents and representatives.

I understand and acknowledge that the Friedberg JCC is not liable for any loss, damage, theft of Personal Property wherever located owned by myself or the persons listed below. Personal Property includes, but is not limited to, personal property located anywhere on the premises of the Friedberg JCC, in lockers, storage, parking lot, and on behalf of myself, my family, any minor child listed below, hereby expressly waive any claim(s) which we may have against the Friedberg JCC arising from or as a result of any such loss, damage, or theft.

I permit the free use by the Friedberg JCC in any manner whatsoever of my name and family members' name(s) and photos, without compensation paid to me or my family members.

If the member is under the age of eighteen (18), this form must be signed by a parent/guardian. I HAVE READ, FULLY UNDERSTAND, AND VOLUNTARILY SIGN THIS RELEASE, WAIVER, AND INDEMNITY AGREEMENT. I UNDERSTAND THAT I AM EXECUTING THIS RELEASE FOR MYSELF, MY CHILD OR WARD, (AND ON BEHALF OF HEIRS, PERSONAL REPRESENTATIVES AND ASSIGNS) AND UNDERSTAND THAT I AM GIVING UP SUBSTANTIAL RIGHTS, INCLUDING THE RIGHT TO SUE. Teen Code of Conduct

The Barry & Florence Friedberg Jewish Community Center (JCC) is dedicated to creating a safe, respectful, and welcoming environment for all members, staff, and visitors. We expect all teens to behave in a responsible and respectful manner while using our facilities or participating in any of our programs. This Code of Conduct outlines expectations and policies that must be adhered to by all teen members.

- 1. Membership Eligibility:** Teen members must apply for the appropriate membership category based on their age. Membership is subject to revocation without refund if the member does not qualify for the membership category for which they applied.
- 2. Membership Cancellation:** To cancel a teen membership, a 30 day notice prior to the 1st of the month is required by completing the cancellation form provided by the membership department.
- 3. Check-In Procedure:** All members are required to scan in using their barcode through the My J App upon entering the building. This helps ensure proper access and security within the facility.
- 4. Membership Fees:** Membership fees are non-refundable and non-transferable.
- 5. Search & Background Check:** The JCC reserves the right to search individuals and their property if necessary for safety and security reasons. The JCC may also perform a background check on any member or prospective member, when deemed appropriate.
- 6. Identification Requirement:** All individuals aged 16 and older must present a valid photo ID (e.g., driver's license) when applying for membership.
- 7. Dress Code:** Proper attire must be worn at all times. Shirts and sneakers are required when using the fitness center. Crocs are not acceptable footwear for the fitness center. Swimwear is appropriate only in designated pool areas.
- 8. Facility Usage & Scheduling:** Members are expected to adhere to posted schedules for using all facilities, including the gym, café, public areas, pool, fitness center, etc.
- 9. Respectful Behavior:** We expect all members to behave in a mature, responsible, and respectful manner at all times. This includes treating other members, staff, and visitors with dignity and kindness.
- 10. Reporting Concerns:** Members are encouraged to report any suspicious or inappropriate behavior to a JCC staff member. Staff members are available to assist and ensure a safe environment for everyone.
- 11. Posting Restrictions:** Members are not allowed to post flyers, posters, or announcements on any JCC bulletin boards without prior approval from the JCC staff.

12. **Prohibited Behavior:** The following actions are strictly prohibited and may result in immediate removal from the premises and potential suspension or revocation of membership:

- **Verbal Abuse:** Use of angry, vulgar language, name-calling, shouting, or swearing.
- **Physical Aggression:** Any form of physical contact intended to harm or intimidate another person.
- **Sexual Conduct:** Any demonstration of sexual activity or sexual contact.
- **Harassment:** Bullying, intimidation, or threatening behavior by words, gestures, or body language.
- **Theft and Property Damage:** Theft or destruction of property.
- **Weapons:** Carrying or concealing any object perceived to be a weapon.
- **Substance Use:** Smoking, vaping, or possession of illegal substances or alcohol on JCC property.
- **Loitering:** Hanging out without purpose or permission in or around the JCC.
- **Inappropriate Conduct:** Any other behavior deemed inappropriate, threatening, or offensive by JCC staff.
- **Unauthorized Access:** Aiding or abetting unauthorized entry by non-members.
- **Conflict of Interest:** Engaging in activities that conflict with JCC services, such as offering personal training or other services without authorization.

13. **Consequences of Misconduct:** Any member found in violation of the above policies may have their membership suspended or revoked without refund. The JCC also reserves the right to remove any member from the premises for inappropriate behavior.

The JCC, through its Executive Director and Board of Directors, reserves the right to remove from the premises any individual acting in an inappropriate manner and further reserves the right to suspend and/or cancel the membership of any such person without refund.

I have read and understand the JCC's Member Code of Conduct. I agree to abide by the rules described above and understand I may be subject to removal and/or suspension if I violate any of these rules.

By my signature below, I release, hold harmless, and indemnify the Barry & Florence Friedberg JCC, as well as its agents and employees, from and against any liability on their part, of any kind whatsoever, which may arise in any manner whatsoever, from my use of the JCC's facilities.
